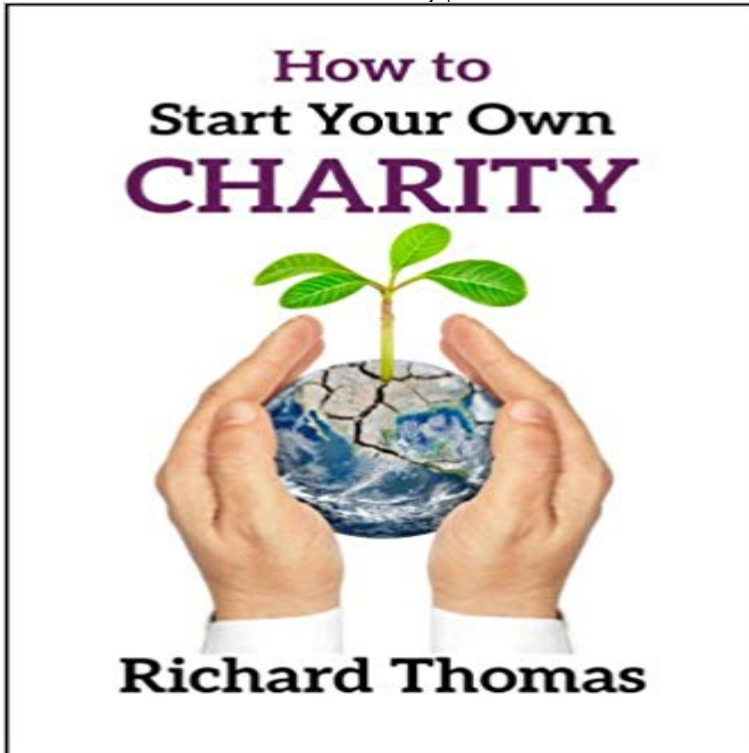


How to Start Your Own Charity: A detailed guide to researching, developing and registering a Charitable Trust with the Charity Commissioners of England and Wales
